Dr. Michael W. Faulkender

Dr. Michael Faulkender was nominated in March 2018 to be Assistant Secretary for Economic Policy at the US Department of Treasury and is currently awaiting Senate confirmation. He joined the Department of Treasury in February 2019 as the Principal Deputy Assistant Secretary. In that role, Dr. Faulkender advises the Treasury Secretary on current and prospective economic developments and assists in the determination of appropriate economic policies.

Prior to joining Treasury, Dr. Faulkender served as the Associate Dean of Masters Programs and a Professor of Finance at the Robert H. Smith School of Business at the University of Maryland. As Associate Dean, he oversaw MBA and Specialty Masters Programs offered by the Smith School. Dr. Faulkender's academic research lies at the intersection of finance, economics, and public policy. It has been published in leading academic journals and been cited several times in the financial press including the Wall Street Journal, Washington Post, and New York Times. His research has received numerous academic prizes, and he served as an Associate Editor of the Journal of Finance.

In addition to the Smith School, Professor Faulkender has also held faculty positions at the Olin School at Washington University in St. Louis, the Kellogg School at Northwestern University, and the Wharton School at the University of Pennsylvania. Dr. Faulkender holds a Bachelors Degree in Managerial Economics from the University of California, Davis and a PhD in Finance from Northwestern University.

Julia Anastasio is Executive Director and General Counsel for the Association of Clean Water Administrators, a position she has held since 2014.
